This matter came before the Court on the Plaintiff's request for a Temporary Injunction submitted in conjunction with the Temporary Restraining Order granted to the Plaintiff on March 22, 2012 in accordance with Rule 65 of the SCRCP. Prior to the hearing on this matter, counsel informed the court that a consent agreement had been reached to fully resolve this matter. After consideration of this consent request and the materials filed in connection with this action, I hereby find and conclude as follows:

- 1. This Court has jurisdiction over the parties and the subject matter of this action, and venue is proper.
- 2. The monies ("Funds") at issue in this action are currently located at Southern First Bank,
  National Association ("Bank") in Greenville, South Carolina, 100 Verdae Boulevard,
  Suite 100, Greenville, South Carolina (incorrectly identified in the caption as "Southern
  First Bancshares, Inc.") and known in the Greenville, South Carolina market as

- "Greenville First Bank" in the bank account ("Account") identified in Exhibit "A" attached hereto and incorporated by reference herein.
- 3. The Parties agree and authorize the transfer of the Funds from the identified Account at the Bank to the account specified herein. The Parties further agree and authorize the continued hold on the account to prevent any and all access to the Funds until such time as they may be transferred as provided in this Order.
- 4. As evidenced by the signatures below, the Plaintiff and all of the named Defendants consent to the requested relief in this matter.

Accordingly, based upon the foregoing and the laws of the State of South Carolina, this Court finds that sufficient grounds exist for all of the requested relief in this matter.

### IT IS THEREFORE ORDERED, DECREED and ADJUDGED THAT:

- (1) The State of South Carolina's Motion for Temporary Injunction is hereby GRANTED;
- (2) Defendant Wilson and Defendant Atlantic Bullion & Coin, Inc. are hereby enjoined from withdrawing, liquidating, transferring or otherwise having access to the Funds during the pendency of this case, irrespective of the Funds being moved by Bank to as set forth in paragraph (3) below;
- (3) Bank is hereby ordered to transfer all Funds in the Account to the South Carolina Attorney General's Office to be placed in an interest bearing account for the benefit of the investors and maintained until a receiver is appointed in this matter;
- (4) The injunction granted in this matter is binding upon the Defendants, their officers, agents, servants, employees, and all other persons who receive actual notice of the order granting the temporary injunction by personal service or otherwise;

- (5) This temporary injunction is to remain in effect until such time as there has been a final adjudication on the merits of this case; and
- (6) Plaintiff is not required to post a bond or other security as a result of the granting of a temporary injunction in this case.

AND IT IS SO ORDERED.
